I am honored and humbled by the opportunity to continue to serve UCM and our community as Board Chair," says Charles O'Connor. "UCM's dedicated staff works tirelessly to fulfill its mission to provide people in need with a helping hand. Our programs help children, adults, and families achieve self-sufficiency. We are fortunate and grateful that we live among caring community members who open their hearts and share their resources to help people who are struggling. UCM continues to

need the community's support, and I would like to ask all my friends and neighbors in the Mount Vernon area to join me in supporting UCM in 2016. We have so many opportunities to participate."

"UCM has a long and impressive history of providing critical programs and services to vulnerable children, youth, families, and adults," says UCM Executive Director Nichelle A. Mitchem. "There continues to be a great need for UCM's programs and services by residents in the Mount Vernon community. It is a privilege to serve with such a dedicated Board of Directors. We are extremely grateful for their service and leadership in UCM's efforts to improve the quality of life for children, youth, and families living in poverty."

According to recent US Census data the percentage of children living in poverty in the state of Virginia is on the rise. Poverty imposes far-reaching hardships, not only on the poor but on all who share their communities. "Child poverty is too costly to continue," Mitchem continues. "Research shows that children and youth who grow up in poverty suffer detrimental and lifelong consequences, including a decrease in the likelihood of graduating from high school and an increase in the likelihood of becoming a poor adult who suffers from poor health and becomes involved in the criminal justice system. These negative outcomes reportedly cost the nation at least half a trillion dollars a year in lost productivity and increased health and crime costs. Most of these children have parents who work, but low wages and unstable employment leave their families struggling to make ends meet."

This year, UCM is putting a special emphasis on our programs that help adults obtain gainful employment and children as well as youth not only grow but also thrive. When UCM's clients and other vulnerable people are provided with a chance to earn a living wage, they are able to meet their families' immediate needs. This type of employment offers parents a sense of pride, stopping the cycle of poverty for their children and themselves. This opportunity has afforded families access to earning a living wage, an indispensable weapon in the fight against childhood poverty and hunger.

A brief biography follows for each of the new officers and new board members:

**Charles O'Connor, Esq.**, is UCM Board Chair and has served on the UCM Board since March 2011. He retired as Partner in Morgan Lewis' Labor and Employment Practice, focused on labor-management relations, particularly collective bargaining. O'Connor has a bachelor's degree from College of the Holy Cross and a law degree from Boston College. He has been involved with Holy Trinity Church in Washington DC and the Washington Jesuit Academy, and has participated in pro bono legal representation for the DC Bar. O'Connor and his wife Linda live in the Belle Haven neighborhood of Alexandria.

Janet C. Heddesheimer, Ph.D., is Board Vice Chair and has served on the UCM Board since December 2013, when she retired from The George Washington University as counseling professor emerita. During her 40-year tenure, she served in many academic and administrative roles including teaching numerous graduate counseling classes, serving one term as a department chair, and 24 years in dean roles as assistant and associate dean, academic associate dean, senior associate dean and twice acting dean. She is a licensed Professional Counselor in the State of Virginia and a National Certified Counselor. A graduate of Coe College with a B.A. in English, she earned both her M.A. in Counseling and Guidance and her Ph.D. in Counselor Education at The Ohio State University. Heddesheimer and her husband Jon live in the Mason Hill neighborhood of Alexandria.

Joseph S. Conti, M.B.A., is Board Treasurer and has served on the UCM Board since December 2012. He is a retired senior banking executive, retiring in 1992 as a Senior Vice President with Bankers Trust Company after a 23 year tenure. In retirement he has served as a financial services consultant primarily to the Polish American Enterprise Fund (PAEF) in Poland, as well as other clients in Poland and Russia. Conti has served as a board member and officer at several organizations in both New York and the greater DC metro area. He is a member of the Emeritus Board of the Children's Law Center in Washington DC and of the Alumni Board of Doorways for Women and Families in Arlington VA.
